Waite Park Community Council Security Rebate Program

Summary: To provide an incentive for property owners for basic security enhancements to make Waite Park more secure and less attractive to all kinds of criminals, the Waite Park Community Council, through the NRP program will provide a rebate for the first \$50 in expenses for eligible improvements.

Rebate Criteria: All properties in the Waite Park Neighborhood, both residential and commercial, may receive a rebate without regard to participation in other or previous WPCC programs. Multiple applications may be submitted, but the total of rebates for any property is limited to \$50 per property. The Program begins January 1, 2009 and closes December 31st, 2010, or when the funding pool is exhausted. Only items purchased or work performed after the start of the program is eligible for a rebate. WPCC reserves the right to verify through inspection that claimed work/purchases were, in fact, installed.

Eligible Improvements:

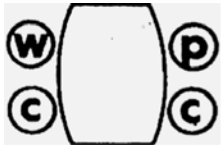
- Exterior security/motion lighting including any necessary wiring and electrical work
- Exterior steel security doors, including garage access doors
- Deadbolt locks on exterior doors, including garage access doors
- Smoke detectors and/or carbon monoxide (CO) detectors
- Window or sliding door security locks or security restraints
- Security bars on garage windows or on windows not facing the street
- Initial installation of a home security system/service, but not the monthly monitoring fees.

NOT Eligible:

- Storm or combination doors not of the all-steel “security” type, even if lockable.
- Tools
- Rental charges
- Personal installation time or “sweat equity”
- Security system monthly monitoring or service fees
- Batteries or other consumables

Mechanism: WPCC makes available a Security Rebate application form. Property owners submit completed forms, along with *original* receipts. WPCC member verifies documents and receipts for compliance. WPCC completes rebate check to be signed by someone different from the verifying Board member. The check is copied for WPCC records and delivered to property owner. WPCC retains all submitted forms and attachments. Property owners may bring disputes before the WPCC Board or Executive Committee.
